TERMS AND CONDITIONS

1. The promoter of this competition and prize is Safecall Limited (company number: 03769031) whose registered office is 100 Bishopsgate, London, EC2N 4AG ("**Safecall**").

The Prize

2. Three winners will receive 1x £50 Amazon voucher each, (the "**Prize**").
3. The terms and conditions in relation to the provision and supply of the Prize are not subject to negotiation.
4. Safecall reserves the right to replace the Prize with an alternative prize of equal value if circumstances beyond Safecall's control makes it necessary to do so.

How to enter

5. The opening date for entries is 9.30am= on 11 October 2022. The closing date of the prize draw is 5.30pm on 31 October 2022 (the "**Prize Draw**"). Entries received after this time will not be **valid or accepted for consideration**.
6. The Prize Draw is free to enter and no purchase is necessary.
7. All entries for the Prize Draw must be submitted via an online webform which can be found on Safecall's website or on the CGI website.
8. Safecall accepts no responsibility whatsoever for entries of the Prize Draw not successfully completed or for entries that are lost, mislaid, damaged or delayed, due to any cause whatsoever, including but not limited to a technical fault, technical malfunction, computer hardware or software failure, satellite, systems, network or server failure of any kind or if for any reason a technical interruption, fault or Safecall site failure occurs when submitting an entry online.
9. Entrants into the Prize Draw shall be deemed to have accepted and agreed to be bound by these terms and conditions upon entry. Safecall reserves the right to refuse entry, or refuse to award the Prize to anyone in breach of these terms and conditions.

Eligibility

10. The Prize Draw is open to new customers to Safecall, and existing customers of Safecall will not be eligible to enter the Prize Draw or any third party directly associated with administration of the Prize Draw.
11. Only one entry per company is permitted. Entries on behalf of another company will not be accepted and joint submissions are not allowed.
12. Safecall reserves the right to check validity and reject entries with reasonable cause.

The Prize Draw

13. A winner of the Prize Draw will be chosen by random draw supervised by an independent person on 4 November 2022 ("**Draw Date**").
14. The winner will be notified by email or telephone (using details provided at entry) before 11 November 2022. The winner must provide written confirmation that they have accepted the Prize ("**Acceptance**") within fourteen (14) days of being notified. If the winner does not respond to Safecall within fourteen (14) days of being notified by Safecall, then the Prize for that winner will be forfeited and Safecall will be entitled to select another winner in accordance with the process described above.
15. The Prize is non-exchangeable, non-transferable and no cash alternative is offered. The winner must not sell or auction the Prize to a third party.
16. The decision of Safecall regarding any aspect of the Prize and/or the Prize Draw is final and binding and no correspondence shall be entered into about it.
17. Safecall reserves the right at any time and from time to time to hold void, cancel, suspend, amend, modify or discontinue, temporarily or permanently, the Prize with or without notification where, in Safecall's sole opinion, it becomes necessary to do so. The decision of Safecall as to what shall be necessary is final and binding and no correspondence shall be entered into on the same.
18. Safecall may use photos, names, counties and countries of the winner in future publications and publicity, and may require the winner to take part in promotional publicity including without limitation being filmed, an interview, photoshoot etc.

Limitation of liability

As events may occur that render the competition itself or the awarding of the Prize impossible due to reasons beyond the control of Safecall, Safecall reserves the right to change or withdraw the competition and/or Prize at any time and the entrant agrees that no liability shall attach to Safecall as a result thereof.
20. The Contracts (Rights of Third Parties) Act 1999 is excluded.

Governing law
